WILLIAM CARROLL QUIGLEY, of the City of Washington, District of Columbia, being of sound and disposing mind, memory and understanding, do hereby make, publish and declare this instrument as and for the first Codicil to my Last Will and Testament, hereby expressly approving, confirming and ratifying in all respects said Last Will and Testament bearing date the 72 day of June. 1960, except as herein modified.

FIRST: I give and bequeath to my son, THOMAS FOX QUIGLEY, absolutely, provided he shall have attained the age of Thirty (30) years, all personal property to which I may be entitled at the time of my death, or which I may have received as a beneficiary, under the Last Will and Testament of my wife, LILLIAN F. QUIGLEY, and which she in turn inherited from her mother, CATHERINE FOX.

If my said son shall not have attained the age of Thirty (30) years, then and in that event, I give and bequeath said personal property to my said Trustee for the benefit of my said son, THOMAS FOX QUIGLEY, upon the same terms and conditions as set forth in my Last Will and Testament bearing date the day of June, 1960, provided said Trust for this portion of his inheritance shall not terminate until he has attained the age of Thirty (30) years.

It is my purpose to preserve intact said property and in such manner that it may be identified or segregated from my general Estate. If, however, at the time of my death, such property cannot be identified by my Executor (whose identification of such property shall be final), I give and bequeath to my said Trustee in and upon the Trust aforesaid, the value of such property, or portion thereof as may be identifiable, said value to be fixed at that shown in the Final Account filed in the Estate of the said Catherine Fox.

SECOND: I hereby revoke the second paragraph of Article TENTH, providing for the appointment of my alternate Executrix and/or Trustee, and substitute the following in lieu thereof:

> "In the e vent my said wife predeceases me, or in the event she shall in any way be unable to assume or continue the duties of Executrix, or in the event of her death after assuming such duties, then and in any of those events, I hereby nominate, constitute and appoint HARRY J. HOGAN as and for the Executor and/or Trustee of this my Last Will and Testament".
