COMPROMISE OF WILL CONTEST

THIS AGREEMENT made this and day of sign, 1911, by and between Lillian Fox Quigley, party of the first part,

Denis Carroll Quigley, party of the second part, Thomas Fox

Quigley, party of the third part, and Helen Elizabeth Veit, party of the fourth part, witnesseth:

WHEREAS, William Carroll Quigley, also known as Carroll Quigley, departed this life on the third day of January, 1977, leaving a paper writing entitled "Last Will and Testament of William Carroll Quigley, "dated June 7, 1960, in which decedent's wife, the said Lillian Fox Quigley, is named Executrix; a paper writing entitled "First Codicil of William Carroll Quigley," dated August 15, 1963; and a paper writing entitled "The Last Will and Testament of Carroll Quigley of Washington, D.C.;" dated April 16, 1973, which names no Executor; and

WHEREAS, the said William Carroll Quigley left as his only heirs at law and next of kin his sons, the said Denis Carroll Quigley and Thomas Fox Quigley, and his widow, the said Lillian Fox Quigley; and

WHEREAS, under the paper writing entitled "Last Will and Testament of William Carroll Quigley," dated June 7, 1960, the decedent's entire Estate other than his automobile is devised and bequeathed to his surviving wife, the said Lillian Fox Quigley; and

WHEREAS, the provisions of the paper writing entitled "First Codicil of William Carroll Quigley," dated August 16, 1963, are ineffective because decedent was survived by his wife, the said

Lillian Fox Quigley; and

WHEREAS, according to the paper writing entitled "The Last Will and Testament of Carroll Quigley of Washington, D.C.," dated April 16, 1973, the said William Carroll Quigley bequeathed to the said Helen Elizabeth Veit all his "scholarly books and papers, including periodicals, research notes and lecture notes, the copyrights [he had] on books, and all finished or partly finished books and articles: and also all money or properties which at the time of his death were in his savings account (No. 4-173-10-4), and the safe deposit box that he jointly held with the said Helen Elizabeth Veit, at the National Bank of Washington; and

WHEREAS, the said paper writing dated April 16, 1973, does not revoke former Wills or Codicils, does not appoint a Personal Representative and does not dispose of the residuary Estate; and

WHEREAS, the said Lillian Fox Quigley, believing that she has sufficient grounds to support a Caveat to the admission of said paper writing dated April 16, 1973 to probate, either as a Last Will and Testament or as a Codicil to the paper writing dated June 7, 1960, is presently considering either the filing of a Caveat to said paper writing dated April 16, 1973, or the renouncing of the bequests and devises made to her by the said paper writing and the taking instead of her dower and legal share of the Estate of the said decedent, or the petitioning of the Court to admit to probate only the paper writings dated June 7, 1960, and August 15, 1963, which would leave to her the entire Estate of the said decedent, except his automobile; and

WHEREAS, the said Helen Elizabeth Veit believes that she has sufficient grounds to prevent the issuance of Letters

Testamentary to the said Lillian Fox Quigley; and

WHEREAS, the heirs at law and next of kin and the said

Helen Elizabeth Veit desire to settle the controversy which has

arisen and to have the Estate distributed amicably;

NOW, THEREFORE, in consideration of the premises and the mutual promises and covenants herein recited, it is agreed by the parties hereto:

- 1. Lillian Fox Quigley, Denis Carroll Quigley and Thomas
 Fox Quigley agree to refrain from filing any Caveat to said
 paper writing dated April 16, 1973, and all the parties hereto
 agree to consent to the admission to probate as the Last Will
 and Testament of the decedent the paper writing entitled "Last
 Will and Testament of William Carroll Quigley," dated June 7, 1960,
 and to the admission to probate as Codicils thereto the paper writing entitled "First Codicil of William Carroll Quigley," dated
 August 15, 1963, which would be admitted as a First Codicil to
 the Last Will and Testament of said decedent, and the paper writing
 entitled "The Last Will and Testament of Carroll Quigley of
 Washington, D.C.", dated April 16, 1973, which would be admitted
 as a Second Codicil to the Last Will and Testament of said decedent.
- 2. The said Lillian Fox Quigley agrees not to renounce the devises and begreats made to her under any of said paper writings.

- 3. All parties hereto agree to have Letters Testamentary issued to the said Lillian Fox Quigley as the nominated Executrix under the "Last Will and Testament" of the decedent dated June 7, 1960, and further agree that the bequests to the said Helen Elizabeth Veit contained in the paper writing dated April 16, 1973, shall be promptly honored pursuant to the attached Agreement which the said Lillian Fox Quigley and Helen Elizabeth Veit made and executed on the 11th day of August, 1977.
- 4. It is further agreed that the said Helen Blizabeth
 Veit shall pay, from the legacy given her under the paper writing
 entitled "The Last Will and Testament of Carroll Quigley of
 Washington, D.C." dated April 16, 1973, and if that legacy is
 insufficient, from her own funds, such inheritance taxes as may
 be assessed upon her distributive share of the Estate and her
 proportion of the Federal Estate Tax which may be assessed on
 the real estate and any other property which was sweed jointly
 by her and the decedent and which will be reported in the
 Federal Estate Tax Return to be filed by the Executrix of the
 said decedent's Estate.
