## AGREEMENT

- 1. Prior to July 15, 1977, a three-member committee shall be formed composed of a nominee of Lillian Fox Quigley, who shall be Jules Davids, and of a nominee of Helen Elizabeth Veit, who shall be Carmen Brissetts Grantham, and a third member jointly chosen by Jules Davids and Carmen Brissette Grayson, who shall be Michael Francis Foley. Mr. Foley shall be ex officio chairman of the committee. In every matter to be decided by the committee, each of the three committee members shall have a full vote. Abstentions shall be counted as negative votes. A twothird vote of this committee shall be necessary to pass any matter. All three committee members must be consulted and have the opportunity to express their opinions and to vote on any measure before it can pass the committee. If any member of the committee should die or resign, the remaining members shall choose a replacement within three weeks of the vacancy's occurring. Whenever any matter is under discussion by the committee, its members may, and are encouraged to, seek the advice and assistance of as many colleagues, friends and admirers of Carroll Quigley as they deem feasible.
- 2. The first order of business of the committee, once it has been constituted and Carroll Quigley's Will has been probated, will be to determine whether to continue using the Georgetown University Library as the place to keep the scholarly books and papers owned by Carroll Quigley when he died, wherever situated. Mrs. Quigley and Miss Veit agree to abide by the decision of the committee in this matter. If the committee determines that the Georgetown University Library is not a suitable repository for some or all of these books and papers, either permanently or for any limited period of time, it shall choose an alternate disposition for them.

- 3. The committee shall deliver as soon as possible to the Georgetown University Department of History, School of Foreign Service, and Library a complete inventory of all the books, articles and papers of or about Dr. Quigley (both published and unpublished) that it knows to be in existence. The committee shall compile this list from the materials entrusted to it by this Agreement and also from other materials that it might come to know of. A copy of this Agreement shall also be given to the above= mentioned divisions of Georgetown University so that when inquiries are made to the University from scholars or others interested in Dr.Quigley's work, they can be forwarded to the committee as they are received.
- 4. The committee will do its best to have as many of Dr. Quigley's unpublished books and articles published. The committee will assist in the arrangement and editing of these materials so as to preserve Dr. Quigley's points-of-view. The committee shall also assist in finding publishers.
- 5. The committee shall recognize Dr. Quigley's express wish that his former research assistant, Helen Elizabeth Veit, be the one to complete his scholarly work and shall assist her in the fulfilling of Dr. Quigley's will. The committee is strictly charged with the duty of making sure that these materials will not be destroyed, lost, mutilated or misarranged.
- 6. To assist Miss Veit in her work, the committee may propose such priorities and schedules as are reasonable. The committee shall review her progress and provide whatever assistance and counsel may be needed. The committee and both parties to this Agreement acknowledge that its most important objective is to preserve and disseminate Dr. Quigley's work as soon, and as far, as possible.

7. The committee will strive to have the Carroll Quigley Chair in the School of Foreign Service adequately funded and staffed by scholars who will honorably represent Dr. Quigley's commitment to excellent undergraduate teaching of broadly interdisciplinary course material by means of outstanding lecturing ability and the soundest academic character.
